NOTIFICATION

Whereas the State Government had re-organised Municipal Council Rohru and Narkanda vide its Notification No. UD-A(1)-4-5/2016-2025 dated 10.03.2026;

And whereas after re-organization of abovementioned Municipalities the Commission re-delimited these Municipalities and issued programme for the updation of electoral rolls Vide Notification No. SEC(F)1-40/2023-Vol-II dated 06.04.2026 in accordance with new delimitation of wards;

And whereas the electoral rolls of Municipal Council Rohru and Nagar Panchayat Narkanda have been finally published today on 27.04.2026 and the copy of reservation order as required under Rule 11 of the HP Municipal Election Rules, 2015 has also been received in the Commission in respect of abovementioned Municipalities;

Therefore, the State Election Commission in exercise of the powers vested in it under Article 243-ZA of the Constitution of India, Section 281 of the Himachal Pradesh Municipal Act, 1994 read with Rule 35 of the H P Municipal Election Rules, 2015, hereby notifies the Election Programme for the conduct of general elections in respect of Municipal Council Rohru and Nagar Panchayat Narkanda. The details of Election Programme is as under:-

1	Nomination papers shall be presented;	On 05.05.2026, 06.05.2026 and 07.05.2026 (between 11.00 am to 3.00 pm). Nomination papers shall be filed at designated places and before the Officers appointed by the Returning Officer for the purpose.
2	The nomination papers shall be	08th May, 2026 (From 10.00 am onwards)



3	A candidate may withdraw his candidature;	On 11 th May, 2026 (Before 3.00 p.m.)
4	The list of contesting candidates showing the name of symbols allotted to them shall be prepared and affixed;	On 11 th May, 2026 immediately after the time of withdrawal is over.
5	The list of Polling stations shall be pasted;	On or before 05.05.2026.
6	The Poll, if necessary, shall be held from 7.00 AM to 3.00 PM;	22.05.2026
7	Counting of votes, in the event of poll, shall be done;	The Counting of votes shall be taken up immediately after the close of the poll at the Municipal Headquarters .
