Whereas the State Election Commission issued a programme vide Notification No. SEC(F)1-40/2023-Vol-II- 7151 dated 18.03.2026 for special revision of electoral rolls of those Gram Panchayats which are not impacted by creation/reorganization;

And whereas the Commission issued a programme vide Notification No. SEC(F)1-40/2023-Vol-II- 8554 dated 02.04.2026 for updation of electoral rolls of those Gram Panchayats which are impacted by creation/reorganization;

And whereas there are certain Gram Panchayats which were initially created/re-organized by the Government and matter went into litigation and the Hon'ble High Court of Himachal Pradesh in CWP No. 3547 of 2026 titled as Mahila Mandal of Village Umri Vs State of HP and other connected matters has directed that their creation/re-organization will not be considered for ensuing general elections and the Department of Panchayati Raj vide letter dated 02.04.2026 has already issued clarification to all the Deputy Commissioners regarding applicability of the Hon'ble Court orders;

Therefore, the State Election Commission in exercise of the powers vested in it under Article 243K of the Constitution of India, Section 160 of the Himachal Pradesh Panchayati Raj Act, 1994 read with Rule 22 of the Himachal Pradesh Panchayati Raj (Elections) Rules, 1994 hereby directs a special revision of electoral rolls of those Gram Panchayats wherein the order of the Hon'ble High Court of Himachal Pradesh passed in CWP No. 3547 of 2026 titled as Mahila Mandal of Village Umri Vs State of HP and other connected matters is applicable.

The programme for special revision is as under:-

1	Filing of claims and objections before the Revising Authority	Up to 13.04.2026
2	Disposal of claims and objections by the	Up to 17.04.2026

3	Filing of Appeals before the Appellate Authority	Up to 20.04.2026
4	Disposal of Appeals by the Appellate Authority	Up to 22.04.2026
5	Final publication of electoral rolls	On or before 24.04.2026

The qualifying age and instructions/directions issued vide Notification No. SEC(F)1-40/2023-8263 dated 18.03.2026 shall be applicable ipso-facto wherever required.
